From the North (via I-294)

Take I-294 South to I-90 West toward Rockford.
Exit at I-90 West.
Take I-90 to Elmhurst Road (South)
Exit at Elmhurst Road (South)
Take Elmhurst Road to Devon Avenue.
Turn right (west) on Devon Avenue.
Take Devon Avenue to Ill. Rt. 83/Busse Road.
Turn left (south) on Ill. Rt. 83/Busse Road.
Take Ill. Rt. 83/Busse Road to first stoplight, which is Mark Street.
Turn left (east) at this first stoplight, Mark Street.
Turn left and proceed to the north end of the building. The building sign says “Center Point Properties”.
Entrance is on north side of building at 2521

From the North (via Illinois Rt. 53)

Heading south on Ill. Rt. 53, Rt. 53 will become I-290 East
Remain on I-290 East to Thorndale Avenue
Exit at Thorndale Avenue.
Turn left (east) on Thorndale Avenue.
Take Thorndale Avenue to Ill. Rt. 83/Busse Road
Turn left (north) on Ill. Rt. 83/Busse Road
Take Ill. Rt. 83/Busse Road to first stoplight, which is Mark Street
Turn right (east) at this first stoplight, Mark Street
Turn left and proceed to the north end of the building. The building sign says “Center Point Properties”.
Entrance is on north side of building at 2521

From Chicago via I-90 (Kennedy Expressway)

Take I-90 west to Elmhurst Road (South)
Take Elmhurst Road to Devon Avenue.
Turn right (west) on Devon Avenue.
Take Devon Avenue to Ill. Rt. 83/Busse Road.
Turn left (south) on Ill. Rt. 83/Busse Road.
Take Ill. Rt. 83/Busse Road to first stoplight, which is Mark Street
Turn left (east) at this first stoplight, Mark Street.
Turn left and proceed to the north end of the building. The building sign says “Center Point Properties”.
Entrance is on north side of building at 2521

From Chicago via I-290 (Eisenhower Expressway)

Taking I-290 West, exit at Rt. 83 North.
Take Ill. Rt. 83 northbound to Mark Street (Ill. Rt. 83 becomes Busse Road)
(Mark Street is the first stoplight beyond Thorndale Ave.)
Turn right (east) on Mark Street
Turn left and proceed to the north end of the building. The building sign says “Center Point Properties”.
Entrance is on north side of building at 2521

From the South (via I-355)

Heading north on I-355, I-355 becomes I-290.
Follow I-290 West (towards Rockford)
Exit at Thorndale Avenue.
Turn right (east) on Thorndale Avenue.
Take Thorndale Avenue to Ill. Rt. 83/Busse Road
Turn left (north) on Ill. Rt. 83/Busse Road
Take Ill. Rt. 83/Busse Road to first stoplight, which is Mark Street
Turn right (east) at this first stoplight, Mark Street
Turn left and proceed to the north end of the building. The building sign says “Center Point Properties”.
Entrance is on north side of building at 2521

From the South (via I-294)

Take I-294 North to I-290 West
Take I-290 West to Ill. Rt. 83
Exit at Ill. Rt. 83 North.
Take Ill. Rt. 83 northbound to Mark Street (Ill. Rt. 83 becomes Busse Road)
(Mark Street is the first stoplight beyond Thorndale Ave.)
Turn right (east) on Mark Street
Turn left and proceed to the north end of the building. The building sign says “Center Point Properties”.
Entrance is on north side of building at 2521

From the West (via I-90, Northwest Tollway)

Heading east on I-90, exit at I-290 East / Ill. Rte. 53 South
Remain on I-290 East to Thorndale Avenue
Exit at Thorndale Avenue.
Turn left (east) on Thorndale Avenue.
Take Thorndale Avenue to Ill. Rt. 83/Busse Road
Turn left (north) on Ill. Rt. 83/Busse Road
Take Ill. Rt. 83/Busse Road to first stoplight, which is Mark Street
Turn right (east) at this first stoplight, Mark Street
Turn left and proceed to the north end of the building. The building sign says “Center Point Properties”.
